According to the USGBC website, James is the first practicing Illinois attorney to be recognized as a LEED AP, which provides him with the expertise to counsel real estate clients seeking to design, construct or renovate building using green or sustainable business practices. He has lectured on green leasing and LEED requirements.

James has worked as an attorney with the United States Environmental Protection Agency. He has extensive knowledge regarding climate change, and was recently quoted in the Wall Street Journal in connection with his visit to Greenland to observe global warming firsthand. James spearheaded LP's efforts to become the first Chicago-based law firm to join the Chicago Climate Exchange, in which the Firm has committed to calculate and offset its carbon dioxide emissions.
